- Applications, amendments or cancellations of postal votes must reach the Electoral Registration Officer at Horsham District Council, Park North, North Street, Horsham, West Sussex, RH12 1RL by 5pm on Tuesday, 21st April 2015.
- Applications to vote by proxy at this election must reach the Electoral Registration Officer at Horsham District Council, Park North, North Street, Horsham, West Sussex, RH12 1RL by 5pm on Tuesday, 28th April 2015.
- Applications to vote by proxy at this election applied for on grounds of an emergency where that emergency occurred after 5pm on Tuesday, 28th April 2015, must reach the Electoral Registration Officer at Horsham District Council, Park North, North Street, Horsham, West Sussex, RH12 1RL by 5pm on Thursday, 7th May 2015.
