

WEST SUSSEX COUNTY COUNCIL
(HORSHAM DISTRICT: VARIOUS PARISHES – VARIOUS ROADS)
(VELO SOUTH) (TEMPORARY TRAFFIC REGULATION) ORDER 2018

NOTICE is hereby given that not less than twenty eight days from the date of this notice, West Sussex County Council intend to make an Order under the Road Traffic Regulation Act 1984, to facilitate Velo South. The effects of the Order will be to:-

(i) prohibit any vehicle, except those authorised by Velo South, from proceeding along the following lengths of road during the specified times:-

Between 0615 and 1145 hours

A283 Petworth/Fittleworth/Stopham/Pulborough – from Haslingbourne Lane to the A29
A29 Church Hill/Sopers Cottages, Pulborough – from the A283 to the A29 London Road

Between 0615 and 1215 hours

A29 Stane Street Pulborough/Billingshurst/West Chiltington – from A29 Sopers Cottages to B2133 Adversane Lane

Between 0630 and 1245 hours

B2133 Adversane Lane/Harbolets Road, Billingshurst/West Chiltington – from the A29 to the B2139

B2139 Coolham Road, Thakeham - from West Chiltington Road to Sincox Lane

B2133 Goosegreen Lane/Billingshurst Road, Thakeham/Ashington – from Coolham Road to London Road

London Road, Ashington – from the B2133 to Hole Street

Between 0645 and 1330 hours

Hole Street, Ashington/Wiston – from London Road to Spithandle Lane

Spithandle Lane, Wiston – from Hole Street/Water Lane to the B2135

Water Lane, Wiston – from Spithandle Lane to the B2135

B2135 Horsham Road/Church Road/Needs Hill, West Grinstead – from Spithandle Lane to Mill Lane

Star Road, West Grinstead

Mill Lane, West Grinstead – from the B2135 to Littleworth Lane

Littleworth Lane, West Grinstead /Cowfold – from Mill Lane to the A272

A272, West Grinstead/Cowfold – from the A24 to the A272

Between 0700 and 1400 hours

Maplehurst Road, Cowfold/West Grinstead/Nuthurst - from the A272 to Park Lane,

Copsale Road, Nuthurst – from Maplehurst Road to Broadwater Lane

Broadwater Lane, Nuthurst – from Copsale Road to Sedgwick Lane/Coltstaple Lane

Coltstaple Lane/Southwater Street, Southwater/Nuthurst – from Broadwater Lane to Worthing Road

Worthing Road, Southwater - from Netherton Close to Church Lane/Bonfire Hill

Between 0715 and 1430 hours

Church Lane/Bonfire Hill, Southwater – from Worthing Road to Marlpost Road

Marlpost Road, Southwater – from Bonfire Hill to Two Mile Ash Road

Two Mile Ash Road, Southwater/Itchingfield – from Marlpost Road to Sandhills Road

Muntham Drive, Itchingfield – from Sandhills Road to Smugglers Lane

Sandmills Road/Plumtree Cross Lane/Westons Hill/Fulfords Road, Itchingfield – from The Hordens to the A264

Between 0730 and 1500 hours

A264 Five Oaks Road, Itchingfield/Slinfold – from Lyons Road to A29 Stane Street

A29 Stane Street, Slinfold – from Hilland roundabout junction to the A281 Guildford Road

A281 Guildford Road, Slinfold/Rudgwick – from Roman Gate roundabout junction to Loxwood Road

Loxwood Road, Rudgwick/Loxwood – from the A281 Guildford Road to the B2133

(ii) prohibit any vehicle from waiting, loading or unloading on the lengths of roads above between 0001 and 2000 hours

Permanent traffic regulation Orders will be suspended where necessary to permit Velo South participants to travel along the intended route

The Order will come into operation at 0001 hours on 23 September 2018 and will continue in force until 2000 hours unless otherwise specified.

Diversions will be marked on site or traffic marshals will direct drivers to alternative routes as necessary.

Pedestrian access will be maintained. Vehicular access for residents may be arranged via CSM Active
