Thank you for the very belated disclosure of the documents which has taken two interventions from the ICO, so far.

I do not think I have overlooked in the documentation now provided the following which appear still to be withheld. On the assumption that this was a mere oversight please can I ask you to provide them within, say, the next week? This is very important because of the evidence of a deliberate cover-up by the Office and councillors Norcross and Lloyd in particular which the two interventions by the ICO have now unearthed. That evidence is contained in the insurers' email disclosed on 1 December 2021 and then even more clearly by the Ms Wise email disclosed on 18 November 2022.

- 1 The email from Ms Wise HDC at 17.45 on 7 September 2021 says Hazel - thank you for the emails – they are useful to see. . You have now disclosed an email from Mrs Roxby on 7 September 2021 timed at 13.59 sending ONE email to Ms Wise. Both the timing of these two messages, despite which other HDC officers had reportedly been consulted and had responded, suggests they had been provided with other emails at an earlier date. Also, the reference by Ms Wise to "emails" suggests that this 7 November email sending one email was not the only email sent to Ms Wise or her colleagues. Please provide the message(s) under which these other copy emails were sent, and any other messages exchanged with HDC. That includes originating from councillors, please. Most likely, Cllr Lloyd.

- 2 On 11 August 2021 the Clerk wrote to the Chairman
I welcome what I hope and believe will be a positive response from the Standard suspect with Personnel's consensus passing this email on as you suggest would

The message which presumably went to HDC as a result falls within 1 above and so that should have been disclosed. Please now oblige.

- 3 The 7 September 2021 message from Wicksteed dealing with irrelevant score 16 and above items which those covering up the situation improperly relied on to publicly question my motives about score 12 and 15 items did not come out of nowhere. What they were asked to do appears to be based on a request which skewed the response to comment on these irrelevant items. Please disclose the full exchange with Wicksteed.
- 4 Throughout there are references to telephone calls. These should have resulted in contemporaneous file notes. None have been produced. Please could you oblige?
