MINUTES

1. APOLOGIES FOR ABSENCE

- 1.1 There were apologies for absence from Cllrs Joanna Norcross, Steve Keogh and Sheri Birch

2. QUESTIONS FROM THE FLOOR.

- 2.1 Rodney Goldsmith queried what is to be discussed at item 6- Draft Contract for 2023-24 on the agenda. He queried if it is for a new 3 year contract or an additional 1 year contract.
The Chairman respond that the discussion is for an additional year contract for 2023-24 as per agenda note.

Mr Goldsmith left the meeting after this item.

3. MINUTES OF LAST MEETING

- 3.1 Cllr Simon Alexander **proposed, seconded** by Cllr Alan Chilver to accept the minutes of the meeting held on the 9th January 2023 as a true and fair record of the meeting. **Agreed.**

4. YOUTH CONTRACT – to discuss with the Youth Service Provider any questions concerning the draft contract.

The Clerk reported that the Steyning Leisure Centre have been contacted and have availability on a Monday evening from 5pm to 7pm. Confirmation of a price for a weekly, term time, booking is awaited, as the clerk was trying to negotiate a discount for a block bookings arrangement. Chris Cook confirmed this would be a welcome development.

The Clerk queried regards the draft contract under item 17 'Specification – requirements' with regards to specific weekly delivery from the Youth Providers. Chris Cook confirmed that the hours would be equivalent to the previous contract and would add a line which confirmed their commitment to this effect.

Cllr Chilver noted that the address for the Upper Beeding Council office requires changing.

Cllr Burstow asked if the staff could use the headings on page 2 when doing the termly report as it would assist with the structure of the report. Chris Cook responded that he would pass the request on to the staff completing the reports.
